Michael Behiels, University of Ottawa, delivered the keynote address at the 26th Annual Conference of the Japanese Association of Canadian Studies held at Nagoya City University. His address was entitled, "Pierre Elliot Trudeau: The Charter of Rights and Freedoms, its origins and Legacy." In addition, Behiels will spend the fall term as visiting professor in the School of Humanities and Social Sciences at Nagoya City University.

Michael Bliss, University of Toronto, delivered the Bilson Lecture at the University of Saskatchewan.

Wendy Cameron and **Mary McDougall Maude** received the J. J. Talman Award for *Assisting Emigration to Upper Canada: The Petworth Project, 1832-1837*. Megan Davies has received a 3-year Wellcome Trust Research Fellowship to be taken up at the University of Glasgow, Centre for the History of Medicine. The title of her project is, "Medical Services in Remote Regions: A Comparative Study of the Scottish Highlands and Rural British Columbia, 1918-1939."

Lori Chambers received the Alison Prentice Award for *Married Women and Property Law in Victorian Ontario*. Awarded by the Ontario Historical Society, the Alison Prentice Award recognizes the best book on women's history published in the past 3 years.

Cornelius J. Jaenen, Honorary Secretary of the Royal Society of Canada and Professor Emeritus of the University of Ottawa, was honoured recently at the Embassy of Belgium for his research, publications and organization of international conferences on Belgians in Canada. By royal decree of King Albert II he was made an Officer of the Order of Leopold II.

Karin MacHardy, University of Waterloo, is spending the fall term at the Institute for Advanced Study, Princeton University.

Ian McKay, Queen's University, received the *Canadian Historical Review's* prize for the best article published in 2000. "The Liberal Order Framework: A Prospectus for a Renaissance of Canadian History" appeared in the December 2000 issue.

Congratulations to **Brian McKillop**. His book *The Spinster and the Prophet*, continues to win awards. Most recently it received the University of British Columbia Medal for Canadian Biography and the City of Toronto Book Award.

Effective April 2001, **Jim Miller**, University of Saskatchewan, was appointed a Tier 1 Canada Research Chair in Native - Newcomer Relations.
