

## AWARDS AND FELLOWSHIPS: NOMINATIONS/ PRIX ET BOURSES : CANDIDATURES

In 1998 **North Atlantic Missiology Project** will award ten places for 24-hour research forums in both the UK and USA, for emerging scholars in the history and theology of Protestant missions, 1740 to 1968. **Massey Medal:** The Royal Canadian Geographical Society invites university departments, learned societies, and other organizations to submit nominations for the Massey Medal, awarded annually by the RCGS. Its purpose is to recognise outstanding personal achievement in the exploration, development or description of Canada's geography; nominees need not be professional geographers. Only Canadian citizens (with some exceptions in special circumstances) are eligible. The Massey Medal is awarded only to individuals, not groups. All nominations for 1998 prize will be considered in early January 1998; the closing date for submissions is December 3, 1997. **Molson Prize: The Social Sciences and Humanities Research Council** is seeking nominations for the Molson Prize, the foremost honour for contributions to Canada's cultural life. The prizes of \$50,000 are awarded annually, one in the field of social sciences and humanities, the other in the arts, in recognition of an exceptional contribution in those fields. The former is administered by SSHRC, while the latter is administered by the Canada Council. The criteria of the selection process stipulate that the candidates must have demonstrated outstanding achievement and that they should still be very active. A university or learned society wishing to nominate an eligible candidate in the social sciences or humanities should provide SSHRC with the name and the latest curriculum vitae, and three to five letters of support, by November 15, 1997. Nominations should be forwarded to Mr. Mel MacLeod, Administrator, Molson Prize, 350 Albert Street, P.O. Box 1047, Ottawa, ON K1V 5V8. Names of the laureates will be announced in March 1998.

**Prix Molson :** Le conseil de recherches en sciences humaines (CRSH) sollicite des candidatures au Prix Molson, le prix le plus prestigieux décerné en reconnaissance de contributions à la vie culturelle canadienne. Des prix de 50 000 \$ sont attribués chaque année, l'un dans le domaine des sciences humaines et l'autre dans le domaine des arts, en reconnaissance d'une contribution exceptionnelle. Le premier prix est administré par le CRSH et l'autre, par le Conseil des arts. Les critères de sélection stipulent que les candidats doivent avoir connu des réalisations

exceptionnelles et être encore très actifs. Les universités ou sociétés savantes désireuses de soumettre le nom d'un candidat en sciences humaines doivent faire parvenir au CRSH le nom et le curriculum vitae du candidat, ainsi que trois à cinq lettres d'appui, d'ici le 15 novembre 1997. **Zdenka Volavka Research Fellowship.** Purpose: to stimulate and support the study of the art history of the indigenous peoples of Africa and North America through field work and to provide opportunities for comparative study through field activities and related collections research. Eligibility: open to graduate students and post-doctoral scholars for the 1997 competition. Applicants must be engaged or proposing to engage in field-based art historical research, which may include comparative study in collections as well as field activities, focusing on the art of indigenous peoples of Africa and/or North America. Submissions must include: brief proposal outline, current c.v., transcripts of all previous work, and 2 letters of reference (one must be from an art historian).
